Security control

It is instituted by Ministerial Decree n. 79-T of 5 July 1999 (G.U. n. 259 of 4 November 1999), a contribution by way of recovery of the costs for security control service to passengers and hand baggage only.

The amount is applied as additional rate to passenger embarkation fees and it is tied up to

the applicability of them, it is paid in fixed amount, and it is not subject to modulation and differentiation as per Law n. 324/76.

- Per each departing passenger 1,81€

It is instituted by Ministerial Decree n. 79-T of 5 July 1999 (G.U. n. 259 of 4 November 1999), a contribution by way of recovery of the costs for security control service to passengers and luggage. The amount is applied as additional rate to passenger embarkation fees and it is tied up to the applicability of them, it is paid in fixed amount, and it is not subject to modulation and differentiation as per Law n. 324/76.

Exemptions

- aircraft crews resulting from the aircraft books or from the general declaration;
- children under 2 years old;
- in-transit passengers without transshipment;
- in-transit passengers with transshipment, provided they do not pass the airport international boundaries;

AIRPORT EXTRA SERVICES

OPENING EXTENSION HOUR

Short extension

350 €/per hour or fraction

Winter Season and Summer Season

ATC operating hours 07.00 LT-21.00 LT – the extension can be requested for the time slot between 21:00 LT and 23:00 LT or between 05:00 LT and 07:00 LT.

Terms and conditions

- Minimum 24 hours' notice is required, after this time GEAC might not be able to guarantee the availability of the service.
- Minimum 24 hours' notice of cancellation required, after this time the extension costs will be charged.
- The tariff does not include the handling fees.

Overnight full extension

2.300 €/service

Opening extension hour outside of the times mentioned above in item "Short extension".

Terms and conditions

- The tariff cannot be provided in the form of hourly payment, but only as a comprehensive service. The Overnight full extension corresponds to a time slot of 8 hours.
- Minimum 48 hours' notice is required. The service is only available upon approval.
- Minimum 24 hours' notice of cancellation required, after this time the extension costs will be charged.
- The tariff does not include the handling fees.
